steeplechasers.org design improvement planning [Lou King / Technology Chair]

steeplchasers.org was reviewed during a marketing seminar at the RRCA convention, and there were some suggestions for improvement

- the site seems geared to members; if the main purpose of the site is to attract new members, sponsors, etc., it should be reogranized
 - o reader needs to know something about the club before the calls to action
 - send members to a separate landing for the details currently on the home page
- get rid of the map background too busy

Additionally, during the club survey, there was less satisfaction with the website design than the other website questions (~60% thought the design was Mostly Good or Fantastic).

Lou is planning the following:

- look at using a different theme Divi was discussed in the past but seems like more work than is needed (reference <u>Website Refresh Budget Proposal</u>)
 - Note the [remove custom] item listed under Effort has been completed
- move the current home page (announcements and calendar) to a "Members Corner" page
- redesign the home page to be more modern, and centered around "calls to action": Join the Club, Sponsor a Race, Join a Training Group, etc
 - may need some design help with this any volunteers? or do we know anyone with web design experience?

Also to reduce the current technical dependency on a single person

- look at using a managed server for the steeplechasers.org site
- also consider if managed server is possible for the loutility webapps scoretility, routetility, membertility, contractility – likely this would be a separate server from steeplechasers.org due to technology differences
